## Instructions for Use

Established Turfgrass and Landscape: Use as a fertilizer for greens, tees, roughs, fairways and ornamentals, three to four times each season. For one pound of nitrogen, broadcast at a rate of 3.63 kg. per 93 sg. meters (8.33 lbs. per 1.000 sg ft.)

New Turfgrass and Landscape Planting and Seeding: Incorporate into top 2-4 inches of soil prior to seeding, sodding or sprigging and landscape planting.

## Application Coverage Rates

For 1 lb. of N/1000 sq. ft. apply 8.33 lbs:

- 1 bag (50 lbs.) covers 6,000 sq. ft.
- 7.25 bags (363 lbs.) covers 1 acre
- 40 bags (1 ton) covers 5.5 acres.

## **Application Guidelines**

- Apply when air temperatures are under 90°F.
- Irrigate after application.
- Do not apply when temperature plus humidity exceed 175.
