Application Guidelines

Turf - apply 3 oz per 1,000 ft² (2 gal/acre) every 10-14 days. Apply in the early morning or late afternoon for best results. Use a spray adjuvant for superior coverage.

Allow foliar product to dry on plant prior to irrigation.

Mixing Guidelines

Shake or agitate before use. Fill mix tank with half of required spray water and turn on agitation. Measure product into tank, add remaining water and other soluble materials. Add a defoaming agent if desired, and adjust pH of tank-mix to neutral if necessary.

Compatibility

Ocean Organics products are compatible with most fertilizers and chemicals but should not be mixed directly with other chemicals.

Mix in spray tanks with water and proper agitation. Conduct a jar test as needed to ensure compatibility with other products before tank mixing.
